VILLAGE ZONING UPDATE

If any of our residents, realtors, or financing institutions have had to deal with zoning in our Village you know of an issue we have had. The Village Administrator, the Mayor, and the Hancock County Regional Planning (HRP) have been working on fixing this issue for over a year and a half. The issue is the zoning map we currently have does not match the current zoning code passed in 2019. The Administrator and HRP have looked at each parcel in the Village and have matched it with the proper zoning district that is in the current code. Some parcels in the Village are zoned, according to the present map, with zoning districts that do not exist in the new zoning code of 2019. This means answering a simple question of "What is this parcel zoned?" a complex and confusing explanation. We have updated the zoning map to match the zoning codes so this simple question can be answered easily. We will be sending out letters to the owners' of parcels that need updated. Changing your zoning to best match the current code **does not affect your property taxes**. There will be a public meeting for your input on any proposed change to any parcel in the coming weeks. We look forward to updating our zoning map to make answering a simple question simple.

- The due date for filing your 2022 McComb Village Income Tax return is April 18, 2023.
- Copies of pages 1 and 2 of your Federal Return and Schedule 1 are required.

LIFEGUARDS FOR THE 2023 POOL SEASON

Are you interested or know someone interested in becoming a lifeguard for the 2023 season? If so, the Village will not be certifying lifeguards as in the past. You will need to contact the local YMCA for certification. If you are hired as a lifeguard for the 2023 season, the Village will reimburse you for your certification class when you complete the pool season. So, keep your receipt!

We are now accepting applications for Lifeguards, Pool Manager and Pool Assistant Manager. Applications can be picked up at the Village of McComb Office or printed off online at our website villageofmccomb.com. Pool Manager and Pool Assistant Manager applications are due by April 21, 2023. Lifeguard applications are due by May 1, 2023.

NORTHWESTERN WATER AND SEWER DISTRICT MCCOMB UPDATE

Thanks to mild weather, work is underway on the McComb Regional Waterline. Construction on this \$7.5 million investment includes boring in North Baltimore, under SR 18, and Deweyville Road. Crews will be wrapping up boring operations soon then mainline work will begin along Deweyville Road/CR 203 and continue through the summer. While most of the waterline work will take place outside of the village limits, other crews continue to work on the sanitary sewer line replacement project throughout McComb. Construction will continue through the spring.
